	<p><b>Constitutional Amendment No. 1</b> <i>Proposed by 102nd General Assembly (First Regular Session) SJR No. 26</i></p> <p>Shall the Missouri Constitution be amended to allow places where individuals, corporations, organizations, and associations provide childcare outside of the child's home to be exempt from property tax? This is intended to make childcare more available, which would support the well-being of children, families, the workforce, and society as a whole.</p> <p>State governmental entities estimate the state's Blind Pension Fund could have annual lost revenue of up to \$400,000.
